

## Breeding Contract for Figaro B 2009

Figaro B \$800 (includes \$200 booking fee)

Initial collection fee is \$250. If the mare requires multiple shipments of semen, additional fees must be paid.

### Terms:

1. \$200 Non-refundable Booking Fee – Payable to Ronda Stavisky (hereafter referred to as Stallion Agent) upon signing this contract. Breeding Fee – Payable before semen shipment.
2. The Mare shall be in healthy and in sound breeding condition and free from infection or disease and that all necessary veterinary examinations and treatments will be carried out in order for the mare to conceive and maintain her pregnancy.
3. All proper paperwork must be completed and all fees paid before the shipping of semen.
4. All shipping costs associated with the shipment of semen will be the Mare owner's expense including the deposit of a valid credit card to cover container deposit (\$300) to be on file with Stallion's veterinary (Dr. Teresa Dwyer, 586 Lonesome Dove, Salado, TX. 76571 –Phone: 254-947-1292) prior to shipping of semen. Equitaner must be returned within 24hr or Mare Owner will incur a \$25/day charge.
5. It shall be the sole responsibility of the Mare Owner to:
  - a. Return the container with 24 hours after usage including all contents of container, excluding semen, with the container or incur a charge.
  - b. Pick up container at designated place and deliver to farm or vet clinic.
  - c. Insure that the semen is administered by a licensed veterinarian on the day of delivery.
  - d. Insure that their veterinarian agrees to follow any and all instructions of the collecting veterinarian, if necessary, otherwise all guarantees become null and void.
  - e. Assume all responsibility for the condition of the mare and bear all risk of loss or damage to the mare by death, illness, injury, infection or otherwise, and agrees to hold Stallion Owner harmless.
6. It shall be the responsibility of Stallion Agent to:
  - a. Deliver live semen provided notification is given as described above\*
  - b. Guarantee live semen to leave the Stallion Agent and release of responsibility to Stallion Agent for delays, cancellations or loss of containers from aircraft or any other means of transportation.

7. Stallion Agent requires that:
  - a. A uterine culture must be performed on the mare by a licensed veterinarian if a mare fails to conceive after 2 cycles.
  - b. Mare must be examined by a licensed veterinarian at 16 and 45 days after last insemination. Stallion Agent must be notified of her pregnancy status at the time or all guarantees are null and void.
  - c. Mare owner must provide a conformation picture and pedigree of mare.
8. It is understood that the service fee is for a live foal that stands and nurses in 2010. The live foal guarantee applies only if the Stallion Agent is notified within one week from the death of foal. A statement must accompany this notice from a licensed veterinarian.
9. If the mare proves to be barren or does not produce a live foal in 2010, the Mare owner will be entitled to return privileges for the same mare or another mare approved by the Stallion Agent that season only. If Mare is to be rebred and mare owner fails to contract the Stallion Agent for semen shipment in 2010, then any and all fees paid shall be nonrefundable and the contract is thereby canceled.
10. It is further agreed that should the said stallion die, be sold by the owner, or become unfit for service before servicing Mare or if Mare named in the contract dies or becomes unfit to be bred then this contract is and shall be null and void.
11. This contract shall not be assigned or transferred and in the event said Mare is sold, the fee if unpaid shall immediately become due and payable and not refund shall be due under any circumstances.
12. When Agent of Stallion signs and returns one copy of this contract, it will be a binding contract on both parties subject to the above terms and conditions.
